 - 103 Co-Sponsors in US House
 - Only MN Representative listed co-sponsors so far are Pete Stauber (R-MN-8), Angie Craig (D-MN-2), and Dean Phillips (D-MN-3)
 - 7/13/19 Bill included as an amendment to the National Defense Authorization Act (NDAA) of 2020, passed House with a vote of 220-198. Now moves to Senate for consideration.
 - US Senate Read on 4/3, Read twice and referred to the Committee on Homeland Security and Government Affairs.
 - 22 Co-Sponsors in US Senate
 - Slow activity
 - Senator Klobuchar co-authored and Senator Tina Smith is a listed co-sponsor

- Senate passed their own NDAA without the 9-1-1 SAVES Act. Going to committee to resolve differences in two bills.
